MODE OF ACTION Actellic 25EC contains pirimiphos-methyl, an organo-phosphorous compound, which kills insects by

contact, ingestion and fumigant action. Once in the insect, pirimiphos-methyl is an acetylcholinesterase inhibitor, causing malfunction of the nervous system.

SPECTRUM OF CONTROL

Actellic 25EC is active on a broad range of pests, including chewing and sucking insects and mites. It has short persistence on green plant tissue and long persistence on inert surfaces. This makes it a valuable insecticide for many agricultural uses as well as for control of stored product insects.

Actellic 25EC is effective on many agricultural pests, including whitefly on glasshouse crops, cotton and vegetables, diamond back moth (Plutella spp) on cabbages, scales and mealy bugs, thrips and many aphids and mites. Its short persistence on plants and in the environment added to its fumigant effect and low toxicity make it especially suitable for pre-harvest treatment, cereal application and for use in forestry.

Actellic 25EC is an excellent insecticide for protecting stored products. It is active against a wide range of pests, including most of the important malathion - resistant strains. It quickly controls existing infestations, and gives long-term protection against re-infestation. Actellic 25EC persists for several months on grain and inert surfaces and it can be applied direct to grain, to walls, floors and ceilings of stores, and to sacks.

STORED PRODUCTS

- Stored products.
- a) Applied in stores as pre-treatment
 - Applied on walls, floors and equipment in stores.
 - Best applied in an empty store.
 - Use 200ml of actellic 25EC per 100m² in 10 litres of water.
- To treat bagged grains, Dilute 100ml of actellic 25EC with 5litre of water b) and apply by knapsack sprayer to 100m²
- For admixture treatment, Apply actellic 25EC at 10-40ml in 1-2 Lt. water/1,000kg grain. Spray using a suitable c) nozzle as the grain is fed into the bins.
- **Hides and Skins**

Dip hide and skin in 2% solution (i.e. 2 litres actelic 25EC in 100litres of water).

COMPATIBILITY

Actellic 25EC is compatible with a wide range of other Twiga products. It may be tank mixed with Duduthrin, Milthane Super and Galben M8-65. It may be mixed with white petroleum oil for mealybug and scale insect control.

HANDLING PRECAUTIONS

Wear eye protection (at least glasses) and rubber gloves when handling the concentrate.

ENVIRONMENTAL HAZARD

Toxic to fish. Do not contaminate rivers, dams and ponds. Toxic to bees. Do not spray when bees are actively foraging.

FIRST AID INSTRUCTIONS

Actellic 25 must not be used by individuals who have been told by a doctor not to work with any organophosphorus compounds. Do not smoke, drink or eat while using Actellic 25. Wear face mask when spraying indoors and work towards exit. Evacuate premises to be treated and thoroughly ventilate before re-entry. To avoid harming bees, warn bee-keepers to close hives during spraying. Wash thoroughly, change and wash work clothes.

Wash out for 10 - 15 minutes in case of eye splashes. If Actellic 25 is swallowed do not make the person vomit. Take the person and the container to a doctor at once.
