

DIRECTIONS FOR USE:

Kumulus® 80% DF is a preventative contact Sulphur fungicide with a broad spectrum of activity. It has a specific action against powdery mildew in roses and tomatoes. Kumulus® 80% DF displays very good plant compatibility at the recommended dosage rate. In addition, Kumulus® 80% DF can also be used as an acaricide to control red spider mites.

MODE OF ACTION:

Kumulus® 80% DF has a predominantly preventive action and is effective through contact and vapour action, and has multi-site contact activity.

MIXING INSTRUCTIONS:

Half fill the spray tank with clean water and start agitation. Shake the product well before opening, measure the required amount of Kumulus® 80% DF and add into the spray tank. Fill the tank with clean water and continue agitation or recirculation. Continue agitation during spraying.

RATE OF APPLICATION/SPRAY INTERVAL

PRE-HARVEST-INTERVAL: 2 days before harvest.

RE-ENTRY INTERVAL: 24 hours, unless wearing protective clothing.

RESISTANCE MANAGEMENT:

Kumulus® 80% DF should be used in accordance with the instructions for use for the target diseases at the indicated conditions. Use Kumulus® 80% DF as part of an Integrated Crop Management strategy incorporating other methods of control. Alternation with fungicides having other modes of action is recommended.

SAFETY PRECAUTIONS:

No special measures necessary if stored and handled correctly. Avoid dust formation, dust can form an explosive mixture with air. Use personal protective clothing. Avoid contact with the skin, eyes and clothing. Ensure thorough ventilation of stores and work areas. When using do not eat, drink or smoke. Hands and/or face should be washed before breaks and at the end of the shift.

STORAGE:

Keep away from food, drink and animal feeding stuffs. Keep out of reach of children. Store in original container tightly closed, in a safe place. Keep away from heat. Protect against moisture. Protect from direct sunlight. Protect from temperatures above: 40 °C

WASTE DISPOSAL:

On emptying the container, triple rinse thoroughly by using an integrated pressure rinsing device or manually rinsing three times. Add washings to sprayer at time of filling. 
